Notes: In April 2010, a sample of 84 of the then-existing approx 300 Type A units showed that 34.5% of them actually housed persons. Some of those persons with disabilities did not have physical disabilities; it was 31% of the units which housed persons with physical disabilities. In January 2015, a sample of 126 Type A units showed that 48.4% of them actually housed persons with disabilities. 30.2% housed persons with physical disabilities who needed the accessible features.
